Official Rules for PCM Credit Union's "Kids Summer Saving Camp" Promotion

THIS PROMOTION IS VOID WHERE PROHIBITED BY LAW.

- 1. Credit Union:** This promotion is being offered by PCM Credit Union, 601 Willard Drive, Green Bay, Wisconsin 54304, 1740 Stephenson Street, Marinette, Wisconsin ("the Credit Union").
- 2. Terms and Conditions:** By participating in the Promotion, you, the participant, ("You") fully and unconditionally accept these Official Rules and agree to become bound by the Official Rules and any decisions made by the Credit Union with respect to the Promotion. Your ability to receive a Prize, as that term is defined below, is contingent upon Your satisfaction of all Promotion requirements as set forth herein.
- 3. Eligibility:** The Promotion is only available for custodial accounts established for Credit Union members legally residing in the United States age 12 and under at the time of entering the Promotion. This Promotion is for natural persons only and any Promotion entries applicable to an account held by any business entity will not be accepted. The Employees and volunteers of the Credit Union its affiliates, subsidiaries, vendors, advertising or promotional agencies, as well as all persons residing in the same household as any of the foregoing, are not eligible for Prizes connected with the Promotion. THIS PROMOTION IS VOID IN RHODE ISLAND, FLORIDA, NEW YORK, AND WHERE PROHIBITED BY LAW, RULE, REGULATION OR ORDINANCE.
- 4. Promotion Period:** The Promotion begins on **July 1, 2019** and ends on **August 13, 2019** (the "Promotion Period").
- 5. How to Enter:** During the Promotion Period You will receive one Promotion entry when you open a qualifying Youth Savings Account with a minimum of \$5.00 at any Credit Union location. Existing accountholders of qualifying Youth Savings Accounts making regular deposits totaling \$40 or more during the Promotion Period will also receive an entry in the Prize drawing. One drawing entry per child, irrespective of the total number of qualifying accounts are maintained at the Credit Union for the child.
- 6. Prize:** One winner will be randomly selected at a drawing held on Tuesday August 13, 2019 that will include all eligible entries received. Your odds of winning depend on the number of entries received. The Credit Union will make efforts to contact the winners via telephone, e-mail or mail service. If the selected individual does not respond by the first Monday following the prize drawing, another winner will be drawn. Certain restrictions may apply.
- 7. Non-Transferable.** No conveyance, substitution or other transfer of the Prize is permitted.
- 8. Responsibility for Prize.** If You win the Promotion prize, You understand and agree that You are solely responsible for the use, care and maintenance of the Prize.
- 9. Publicity:** Except as prohibited by law, by accepting any Promotion Prize, You and Your parent or legal guardian consent to the Credit Union's use of Your name and likeness marketing purposes for no additional consideration. You and Your parent or legal guardian further agree to prepare and execute any additional documents deemed by the Credit Union, in its sole discretion, to be necessary if You win a Promotion Prize.

- 10. Social Media:** The Promotion may be advertised or administered through social media platforms, such as Facebook and Twitter (“Social Media”). Notwithstanding the foregoing, You and Your parent or legal guardian understand and acknowledge that the Promotion is in no way sponsored, endorsed, administered by, or associated with any Social Media platform on which it is offered or advertised. By continuing to participate in the Promotion, You and Your parent or legal guardian further agree to adhere to all rules established by Social Media platforms, expressly agree not to create multiple Social Media accounts or repeatedly post duplicate, or near-duplicate, information and/or links for the purpose of gaining multiple entries in the Promotion. You and Your parent or legal guardian further acknowledge and agree to fully release, indemnify and hold harmless any and all Social Media sites used by the Credit Union for this Promotion from any and all claims, losses and harm as a result of participating in this Promotion, occurring now or in the future.
- 11. Other Requirements.** In the Credit Union’s discretion, Prize winners and their parent or legal guardian may be required to sign and return a declaration of eligibility, additional release of liability, and, where lawful, an additional publicity consent agreement. If a selected individual cannot be contacted, is later deemed ineligible, fails to claim a prize, or fails to return the completed and executed declaration and releases as required, then the Prize will be forfeited and awarded to the alternate account holder selected each month at the times winners are drawn.
- 12. RELEASE AND HOLD HARMLESS. BY ENTERING THIS PROMOTION, YOU AND YOUR PARENT OR LEGAL GUARDIAN AGREE TO RELEASE AND HOLD HARMLESS THE CREDIT UNION, ITS PARENT, SUBSIDIARIES AND ANY OF ITS AFFILIATED ENTITIES, AND EACH OF THEIR DIRECTORS, OFFICERS, EMPLOYEES, ATTORNEYS, AGENTS, AND REPRESENTATIVES FROM ANY DAMAGE, INJURY, EXPENSE, COST, DEATH, LOSS, CLAIM, ACTION, DEMAND, OR OTHER LIABILITY THAT MAY ARISE IN CONNECTION WITH THE PROMOTION, OR RESULTING FROM ACCEPTANCE AND/OR USE OF ANY PRIZE, TRAVEL TO OR FROM ANY PRIZE-RELATED ACTIVITY, PARTICIPATION IN THIS PROMOTION, AND FROM ANY MISUSE OR MALFUNCTION OF ANY PRIZE AWARDED, INCLUDING, WITHOUT LIMITATION, PERSONAL INJURY, DEATH, AND/ OR PROPERTY DAMAGE.**
- 13. Limitations:** By continuing to participate in this Promotion You and Your parent or legal guardian understand and agree that the Credit Union may not be held liable for any lost, late or misclassified entries, or entries containing incorrect or incomplete information. The Credit Union further is not responsible for any problems, existing either now or in the future, related to technical malfunctions concerning any mail network, telephone network or lines, computer, online accessibility, Internet systems or services, servers, computer equipment, or software, including any failures connected with the electronic delivery of notices or other information connected with the Promotion due to traffic congestion on the Internet, connectivity issues with the Credit Union’s website, or any combination thereof. You further agree that the limitations set forth above extend to any injury or damage incurred by You or the owner of any technology or equipment used by You during the Promotion Period, including but not limited to the computer used for downloading any materials in connection with the Promotion. Entries are the property of the Credit Union and will not be acknowledged or returned.
- 14. Disqualification.** The Credit Union reserves the right to disqualify any person tampering with either the Promotion entry process or the operation of the Credit Union website, or for any person otherwise determined as being in violation of these Official Rules or any laws.
- 15. Winner Information.** Prize winner inquiries are accepted and should be sent with a separate, stamped, self-addressed envelope with a written request for information to Dan Wollin at the address listed above.
